# LETTER FROM THE PRESIDENT



I am honored to have served as the president of the Physician Assistant Foundation during 2012, and I am proud of the Foundation's achievements summarized in this annual report. The activities described in the following pages would not have been possible without the assistance of the generous individuals, organizations and corporations that supported the PA Foundation during 2012. It is gratifying to recognize and thank them for their generosity and confidence in the Foundation's efforts to advance the physician assistant profession and promote better health. I am especially pleased to report that the number of individual donors and corporate supporters increased significantly in 2012, 62 percent and 30 percent, respectively, and total revenue increased 22 percent.

2012 was a year of constructive change and renewed purpose for the PA Foundation. In May, we welcomed our new executive director, Lisa Gables, who brings a wealth of experience, expertise, and enthusiasm to the Foundation. We are delighted to have the organization in her capable hands. In September, a strategic planning meeting of the Board of Trustees and staff resulted in revised vision and mission statements, a revamped corporate partner program, and a new operational plan to guide us going forward. During National PA Week in October, AAPA and the PA Foundation convened the first Physician Assistant Corporate Forum designed to engage our corporate partners in thoughtful discussions on key issues affecting healthcare and the PA profession. In December, the Foundation launched its own website — [www.pa-foundation.org](http://www.pa-foundation.org) — amplifying our visibility to AAPA members, the healthcare community, and the general public.

The future is very bright for physician assistants. The U.S. Bureau of Labor Statistics predicts that physician assistants will be the second fastest growing health profession in this decade. Numerous new PA programs are being developed at colleges and universities every year. With this growth in the profession, there must be corresponding growth in AAPA and the PA Foundation. Through innovative strategies, persistent efforts and focused execution, I am confident that we will succeed in accomplishing our goals.

# JOHNSON & JOHNSON SCHOLARSHIP FOR PRE-PA STUDENTS

Limited access to a health professional who is representative of a patient's cultural or linguistic background is associated with poor health outcomes. According to the Center for American Progress, more than 84,000 lives could be saved annually if the healthcare disparity gap were closed. In recognition of this issue, the Physician Assistant Foundation established a scholarship for underrepresented minority pre-PA students, with the goal of increasing diversity in the physician assistant workforce and alleviating disparities in access to healthcare among underserved populations. This scholarship program is made possible by a generous contribution to the Foundation from Johnson & Johnson.

In 2012, the Physician Assistant Foundation awarded two students beginning their PA studies \$25,000 scholarships to support their education. The scholarship recipients were selected based on financial need, academic performance, community service and commitment to providing care in underserved communities.

## BREITMAN-DORN ENDOWED RESEARCH FELLOWSHIP

The Breitman-Dorn Endowed Research Fellowship was established in 1998 through a generous donation from Jerald A. Breitman in memory of his partner Stephen Dorn. The endowment encourages a commitment to research in and about the PA profession. The fellowship provides financial assistance to doctoral candidates who are making a contribution to research on the influence of PAs in medical care.

Karen Graham is working toward a PhD in higher education administration at the University of Toledo's Judith Herb College of Education, Health Science and Human Service. Her dissertation is "Development and Validation of a Measure of Intention to Stay in Academia for Physician Assistant Faculty." The purpose of the study is to address the problem of inadequate PA faculty retention by determining whether the intention of PA faculty to stay in academia can be meaningfully measured. An enhanced understanding of PA faculty retention will assist program directors, senior PA faculty and the professional leadership in developing targeted recruitment and retention efforts for PA faculty.

# GLOBAL OUTREACH GRANTS

## ROBERT K. PEDERSEN GLOBAL OUTREACH HUMANITARIAN ASSISTANCE GRANTS

The Robert K. Pedersen Global Outreach Humanitarian Assistance Grant Program was established in 2005 through a gift from Don and Kathy Pedersen's Family Foundation to create an endowment in memory of Don's father, who was an international businessman. This program provides financial support to projects involving PAs and PA students in humanitarian activities designed to improve the quality of life in underserved areas of developing countries and the United States.

The grants are intended to promote sustainable development in the areas of healthcare and health education for populations and communities in need. Funding is provided for projects that enhance or expand existing programs and provide the participating PAs and students an invaluable learning experience in healthcare delivery, leadership and project management.

The Foundation's global outreach grants have supported worthwhile projects in Africa, Asia, Central and South America, the Caribbean Islands, former Soviet Union countries and the United States. In 2012, grants supported PA-led humanitarian outreach programs in Guatemala, Nicaragua and the Dominican Republic.

Global outreach grants are funded from several sources:

- The Robert K. Pedersen Global Outreach Endowment — The Pedersens have been physician assistants for more than 30 years — Don as professor and director of the University of Utah PA Program, and Kathy as a primary care PA at the Community Health Centers of Salt Lake City.
- Chevron Corporation and other corporate partners
- Individual donors

## 2012 GLOBAL OUTREACH GRANT RECIPIENTS



### Guatemala Rural Health Outreach

Led by Jennifer Coombs, PhD, PA-C, assistant professor in the Division of Physician Assistant Studies at the University of Utah Department of Family and Preventive Medicine, PA faculty and students have been providing assistance to the San Lucas Mission in San Lucas Toliman, Guatemala, for six years. The mission's Rural Health Outreach program is led by local Guatemalan healthcare professionals and trained community health promoters who rotate through 33 small communities surrounding San Lucas Toliman providing basic healthcare services and health education to the indigenous Mayan population. PA students travel to Guatemala and spend two weeks in rural outreach clinics under the supervision of the community health promoters and

University of Utah faculty. According to Coombs, one of the goals of the program is to inspire PA students to long-term involvement in global health and the care of underserved populations. The grant, funded by the Robert K. Pedersen Endowment, is helping sustain the San Lucas Mission's ongoing projects, allowing students to continue to participate in this outreach program.

### Nicaragua Service Learning Project

Each December, an interdisciplinary team of students and faculty from Pacific University's College of Health Professions travels to Nicaragua to help meet the healthcare needs of the elderly population, who often have been abandoned by their families due to extreme poverty or emigration. The goals of the project are to provide direct care for geriatric residents, educate caregivers and community healthcare providers, develop self-sustaining programs, and enhance inter-professional understanding and service delivery among the health disciplines. Under the supervision of faculty, PA students perform health screenings and physical exams, treat injuries and illnesses, provide wound care, write prescriptions and document

follow-up care plans. "This is a unique opportunity for students to learn more about each other, the programs we have at the university, the other professions caring for elders, and other cultures and traditions," said Sara Davis-Risen, PA-C, assistant professor in Pacific University's School of Physician Assistant Studies. The grant, funded by the Robert K. Pedersen Endowment, provided support for the PA students who participated in the 2012 trip and paid for medications and supplies for the project.

### Dominican Republic Medical Service Trip

Since 2009, the Quinnipiac University (QU) PA Program has partnered with Health Horizons International (HHI) on trips to the Dominican Republic to improve access to quality primary healthcare in underserved communities. The goals of the project are to provide medical care directly to the impoverished communities HHI serves and support the organization's Community Health Workers Program and its research on the effectiveness of its community-based medical service trip model. QU PA students perform triage, intake tasks and medical translation, and assist with in-clinic examinations. Each medical service trip provides treatment for acute and chronic illnesses, preventive healthcare services and health education to nearly 500

underserved individuals in HHI's four partner communities. "These trips are medically beneficial to the people we serve; however, in addition, we are also conscious of making sure that our care is perpetuated once we leave," said Kimberly Tschetter, vice president of the QU PA program class of 2013. "By partnering with HHI, we succeed in achieving a system of continuity of care." The grant, funded by a contribution from Chevron, provided support for the PA students participating in the January 2013 trip and paid for medications, medical supplies and training materials for HHI's Community Health Workers Program.





# AWARDS

## CARING FOR COMMUNITIES AWARD

The Caring for Communities Award recognizes and supports the work of PAs, PA students and others making a difference in the lives of people struggling with a variety of healthcare and social issues. Each year, a charity in the host city for AAPA's Annual Physician Assistant Conference is selected to receive the Caring for Communities Award and an accompanying grant to support its work. The recipient must be a 501(c)(3) nonprofit organization that provides needed services to disadvantaged individuals in the community and offers an important educational opportunity and impactful experience to students, faculty and other volunteers.

The Caring for Communities Award is supported by contributions from PAs, PA program student societies and other partnering organizations.



### Second Harvest Toronto, Ontario

Second Harvest is the largest food rescue program in Canada. Its mission is to help feed hungry people by picking up and preparing excess fresh food from restaurants, growers, wholesalers and grocery stores that would otherwise go to waste and delivering it to social service agencies in Toronto. Second Harvest provides fresh and frozen foods for more than 18,000 meals every day to community centers, homeless and domestic



violence shelters, breakfast programs and other organizations. The clients served include at-risk children, seniors on fixed incomes, women fleeing domestic abuse, homeless persons, psychiatric patients and thousands of others who have fallen on hard times. Through its partners, Second Harvest's clients also receive healthcare and social services that they might not have sought on their own.

## PREVENTION AMBASSADOR AWARD

The Physician Assistant Foundation established the Prevention Ambassador Award, in partnership with Pharmavite LLC, to recognize a PA demonstrating outstanding commitment to disease prevention and promoting overall good health in the community.



### **David Kellenberger, MPAS, RD, PA-C Dallas, Texas**

David Kellenberger was the recipient of the Prevention Ambassador Award and a \$15,000 grant to support his work in nutrition and bariatric surgery. The son of a former health food store owner, he has devoted his clinical career to caring for those with nutritional disease. Over a four-year period, he operated on more than a thousand patients, evaluated and managed numerous vitamin and mineral deficiencies pre- and post-surgery, and developed a vitamin repletion protocol. His program includes “Dietary Changes That Matter,” a presentation that focuses on key dietary changes needed to address nutrient shortfalls, including the use of dietary supplements and lifestyle changes with safe and effective protocols. He is using the grant to support a new program directly addressing issues such as patient follow-up, compliance with vitamin and mineral supplementation, reduced fat dietary recommendations and other initiatives that benefit bariatric surgery patients.

## LOCAL HERO AWARD

The Physician Assistant Foundation’s Local Hero Award honors an individual who has demonstrated outstanding service to and/or support of advancing the PA profession on a local level in the city hosting AAPA’s Annual Physician Assistant Conference.



### **Deborah Hellyer, MD Windsor, Ontario, Canada**

Deborah Hellyer was selected to receive the Local Hero Award in recognition of her passionate advocacy in making PAs part of Ontario’s healthcare system, as well as her dedication to and personal involvement in Ontario’s Physician Assistant Initiative. In 2006, Dr. Hellyer, director of the Windsor Regional Hospital’s pulmonary rehabilitation program and a private practice internist and respirologist, was named co-chair of the Ontario Physician Assistant Implementation Steering Committee, created by the Ontario minister of health. While the Canadian military had employed PAs for more than two decades, introducing the profession to Canada’s public healthcare system was a new concept — one that she and other advocates thought would help address the shortage of physicians in Canada. Since 2008, she also has chaired the physician assistant working group of the Canadian Medical Association, which created a tool kit for physicians and government officials that explains the role of PAs and how they can be integrated into a medical team. By 2012, 130 physician assistants were practicing in Ontario across specialties from internal medicine and surgery to endocrinology, pediatrics and long-term care.

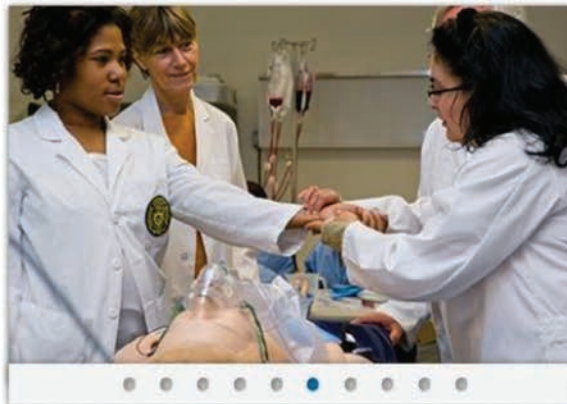
